**Final Hearing of Ordinance 04-17, Prohibition on Parking in Parks and Recreation Facilities**

ORDINANCE AMENDING CHAPTER 173 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF MOUNTAIN LAKES AND CLARIFYING THE PROHIBITION ON PARKING IN PARKS AND RECREATION FACILITIES DURING CERTAIN HOURS

Mayor Holmberg read a statement clarifying the purpose of the ordinance.

Mayor Holmberg opened the meeting to the public

Mr. Fred Kanter, 81 Hanover Road, made comment regarding parking on public land in regards to no being able to reserve a parking space on public property. He stated that the ordinance was a solution in search of a problem. He stated that there is no prohibition against parking in front of private property on the roadway, (two wheels on the curb). He stated that there is a prohibition for parking on public property. He wanted to know what the problem was with parking in the right of way on public property. What is danger? He stated that he does not see the reason for this to be done.

Maria Hunter 128 Kenilworth, stated that she is worried about strange cars parked on borough land at night. She stated that there could be a criminal element, drug sales; you don't know who is parking. She stated that there a lot of families in the area with husbands that travel. She stated that she wanted the ordinance passed.

John Droggitis, 25 Hanover Road, stated that this ordinance is a solution looking for a problem. He was not sure why this ordinance needs to include the pocket parks. The parks exist all over the borough. There are people who park there and there is no danger. He suggested that not allowing the parking there causes a safety issue. He asked the Council not to pass the ordinance.

Sam Horowitz, 75 Kenilworth Road, asked what the ordinance was clarifying. Mr. Oostdyk explained the ordinance. It is to no allow vehicles parking in pocket parks. He stated that he has a park across from his house. He does not want anyone parking there as there is already considerable erosion.

Thomas Marrota, 111 Melrose, stated that he agrees with the clarification in the ordinance. He stated that the pocket parks had vegetation that has been ruined because of the parking on the property.

Steven Shaw, 4 Pointview Place, stated that he was confused regarding the public right of way and public park. Mr. Oostdyk stated that he ordinance prohibits parking overnight in a pocket park or in the right-of-way of a public park. It does not prohibit parking on the right of way in front of someone's home. Mr. Shaw mentioned 4<sup>th</sup> of July parties where people do park overnight. Ms. Barnett stated that you can always call the police department in case there is an event or party and let them know cars will be parked overnight.

Audrey Lane 31 Melrose, said that she appreciated the council taking the time to draft this ordinance keeping in mind the public space both for the beauty and place for kids to play. She stated that her children play in the pocket parks and they have turned into parking lots.

Mr. Joe Plonski, 25 Melrose Road, stated that he was not sure about the comments from the council. He stated that it is confusing to have the ordinance deal with parks and right of ways. He had passed out pictures and asked if the parking shown in the pictures were legal. He asked if the ordinance was good for Mountain Lakes. He stated that he does not own the first 7 feet of his property. He has a single width driveway. The land in front of his property is sloped and he

cannot park there. The land across the street is flat and is safe to park on. He suggested that the ordinance is making an unsafe situation. He stated that the citizens do not understand this ordinance.

Jennifer Merrota, 21 Melorse, passed out pictures of a pocket park near her home that is littered. She made comments regarding parking issues. She stated that there is a safety issue with allowing parking in borough parks overnight. You don't know who is parking their cars there. She stated that parking cars in the parks can leak oil into the grounds. She stated that the parks become mud pits from having only one car parking there. She stated that having a parking lot in front of someone's home is an eyesore.

**COUNCIL REPORTS**

Ms. Korman stated that the Environmental Commission is asking to be able to hire a consultant for several matters being considered. There was a presentation by a vendor providing the water filtration system for the Enclave. Ms. Horst stated that Traffic and Safety met. She stated that one of the things the committee does is monitor paths to school. There was a concern regarding sidewalks by the train station that children use to walk to school. The sidewalks need repair. There was a discussion regarding the movable speed sign and what data it collects. Mr. Barrett stated that Shared Services is working on a resident survey. They are looking at what options are still available for shared services and what services the residents are interested in. Ms. Barnett asked the Recreation Director, Audrey Lane to comment on the Recreation meeting since Ms. Barnett could not attend. Ms. Lane stated that the upcoming summer activities were discussed. She stated that the Trout derby is in its 45<sup>th</sup> year. They discussed the swim program. Summer hiring is in full force. There was a discussion regarding allowing some of the smaller parks to be rented out to residents for parties or events. Mr. Happer stated that Historic Preservation Committee is looking at digitizing documents. The dynamite shed is being renovated and will be used for storage. The Solid waste committee met. They are discussing the service and the pickup zones. Mr. Sheola stated that the King of Kings project is moving along through the Planning Board. At the next meeting environmental and traffic matters will be discussed regarding the project. Ms. Barnett commented regarding a program that the school students are involved in called destination imagination She stated that there were several teams from Mountain Lakes that took first or second place in the State competition and some teams will be moving on to the global competition.
